1.1.General data

The educational program 6B01701 "Kazakh language and literature" was developed by teachers of the department "Kazakh Philology and Journalism" of the Faculty of Philology of the Shakarim Semey University, with the participation of the director of the KSU "Secondary School No. 16 named after T. Amanov" Semey and a 3rd-year student of the specialty Kazakh language and literature from the employer.

Since the main feature of the educational program "Kazakh language and literature" is a program aimed at training teachers in the Kazakh language and literature for schools with Kazakh and non-Kazakh languages of instruction, the main scientific and practical courses of the Kazakh language and literature, along with methodological courses, are integrated disciplines that allow working in Russian-speaking classrooms (Russian and Kazakh languages comparative grammar of languages", "theory and practice of translation", "methods of teaching Kazakh language and literature in Russian schools"). According to the educational program Kazakh language and literature, students also specialize in educational (pedagogical), organizational and managerial, research, publishing, document language management, translation, mass media and other areas of activity.

The educational program provides for the education of a student with special educational needs in the conditions of a higher educational institution, as well as his socialization and integration into society.

1.2.Completion criteria
